





From the Helm

Dear Members of Sailing Singles,

I did say that I would deal with people individually when problems arise, but there are a few issues and more than a few rumors floating around, so this time I'll report to the club as a whole.

Well, it's been quite a ride since the Change of Command. Even before the Board was installed, we had problems at our January 18 raft-up. Since this incident, I think the Board has gone through a year full of emails. At least I hope we have, because the Board has used up a year's worth of time dealing with all of it (at least it feels that way sometimes). I know our decisions weren't popular with everyone, and at times the club seems more polarized than my last pair of sunglasses, but a lot of this was unprecedented, so we reviewed various accounts and grievances concerning the incident and made our decision. Once the rules are passed, we will be able to act more quickly and effectively. We want to concentrate on all members having an enjoyable experience. People join this club for socials and sailing, not animosity and hostility. If you have any feelings like that, keep them at home and away from our events.

Finally, a request from me in regards to the Board: We do have lives. We have agreed to give up part of our lives in the interest of the club. The Social Chair wants to plan parties. The Sailing Director wants to plan sails, and so on. Please appreciate that we have all been pulling double duty trying to resolve existing problems as well as prevent future ones.

Understand that while we may not agree with each other, we do have to respect each other.

In other news:

We are working on the Spring SOS at the Lighthouse Point Marina. Their slips are full at the moment, but once some of their "snowbird" boats are gone, they'll have room for us.

As stated before, the Pink Book is being revised. It may take a while to vote on and incorporate the changes, so we may publish and print the club directory first.

People seem to be happy with Flip-Flops, so we'll be having our Thursday socials there until further notice.
